He practiced antitrust and trade regulation law at a large Washington law firm and was on active duty as a member of the Navy's Judge Advocate General's

JAG Corps during the Vietnam era. He earned his BA in politics and economics from Yale University, his JD from Harvard Law School, and his PhD in political science from Columbia University. He is the author of The Litigious Society Basic Books, winner of the American Bar Association's top literary prize, the Silver Gavel.
